# ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

#### CURE A WORLD, INC.

The undersigned Incorporator, for the purpose of forming a not-for-profit corporation in compliance with Chapter 617 of the <u>Florida Statutes</u>, hereby adopts the following Articles of Incorporation:

### ARTICLE I - Name and Address

The name of the corporation is CURE A WORLD, INC. (hereinafter referred to as the "corporation"). The mailing address of the corporation is 680 Deerhurst Drive, Melbourne, Florida 32940, and the address of the corporation's principal place of business is 680 Deerhurst Drive, Melbourne, Florida 32940.

### **ARTICLE II - Duration**

This corporation shall have perpetual existence.

#### ARTICLE III Purpose

- A. The specific and primary purpose for which the corporation is formed is to create, organize and implement educational activities as an elementary school under the laws of the State of Florida, and specifically: to raise funds to financially supplement health-related research and development.
- B. The general purpose for which the corporation is formed is to operate exclusively under Section 501(c)(3) of the Internal Revenue Code and Regulations (hereinafter referred to as the "Code") and corresponding provision of any subsequent federal tax laws, including for such purposes, the making of distributions or organizations which qualify as tax exempt organizations under the Code.
- C. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any Director or Officer of the corporation or any member of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no Director or Officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation

shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

D. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

## ARTICLE IV - Directors

The Initial Board of Directors shall consist of three (3) individuals who shall have the power to notice, amend, and repeal the Bylaws of the corporation. The number of directors may be increased or decreased from time to time as set out in the Bylaws of the corporation, but the number of Directors shall never be less than three (3). The Directors of the corporation need not be Members. Directors shall be elected by the Members, at annual meetings of the Members. The names and addresses of the initial Board of Directors are:
