**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF  
CURE A WORLD, INC.**

The undersigned, as Incorporator and President of CURE A WORLD, INC., does hereby certify that the Amendment provided for herein was adopted by the directors of the corporation on the 14th day of January, 2004, and that the number of votes cast was sufficient for approval. The corporation has no members.

**1. Amendment Adopted:**

(a) Article III, Subparagraph A of the Articles of Incorporation is hereby amended to read as follows:

**"ARTICLE III Purpose**

A. The specific and primary purpose for which the corporation is formed is to create, organize and implement activities as a fund-raising organization under the laws of the State of Florida, and specifically to raise funds to financially supplement health-related research and development."

2. All other provisions of the Articles of Incorporation remain the same as originally filed.
