ARTICLE III: This Corporation is organized and operated exclusively for Public Benefit, Charitable, Educational, Religious, and Scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt Organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose is to support and spread the message of Islam in north America in the way that does not contradict in whole or in part with the teachings of the holy Quraan, and the Sunnah (the tradition of the prophet Muhammad, May Peace and Blessings of Allah be upon Him) as understood and applied by the well-known Sunni scholars of Islam. The Community of East Orlando and its neighborhood is the principal beneficiary of these services. The organization will also provide its members and the community at large with cultural, religious, social, and recreational services.

ARTICLE VIII: Other Provisions: No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of the document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IX: Dissolution

The corporation may voluntarily dissolve its articles of incorporation. Upon the dissolution of the organization, the assets of the corporation in the process of dissolution shall be applied and distributed as follows: (1) all liabilities and obligations of the corporation shall be paid, satisfied, and discharged. (2) Assets held by the corporation upon condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred or conveyed in accordance with such requirements. (3) The remaining assets, if any, of the corporation shall then be distributed only for tax-exempt purposes to one or more Sunni Muslim organizations, which is/are: (1) Tax exempt under Section 501 [c] (3), Internal Revenue Code AND (2) Organized and operated exclusively for similar purposes such that of University Cultural Center, Inc. as indicated in Article III above.
