Articles of Incorporation of Common Ground Community Church

Pursuant to section 617.0202, Florida Statutes, the articles of incorporation are set forth as follows:

Article I

The name of the corporation is Common Ground Community Church Inc. of The Christian and Missionary Alliance, Lake Mary, Florida.

Article II

The office of the corporation, where all mail will be received, is located at P.O. Box 952377, Lake Mary, Florida 32795.

Article III

The corporation is a not-for-profit corporation, organized and operated exclusively for religious purposes, is not formed for pecuniary profit or financial gain and no part of the assets, income or profits of the corporation is distributable to or inures to the benefit of its members or officers or any private person.

Should this corporation cease to exist as a corporate body in affiliation, cooperation, or connection with the parent organization, then all of the real and personal property, appurtenances, and effects then owned or held by this corporation shall revert to and become the property of the incorporated or supervising body of The Christian and Missionary Alliance within whose jurisdiction said corporation is located or with which it is affiliated.

Article IV

The qualifications for members and the manner of their admission shall be regulated by the corporation by-laws. The method of election of directors is as stated in the bylaws.

Article V

Corporate powers are limited as pursuant to Florida Statutes 617.0501 and 617.0302.

Article VI
