

This Second Amendment to the Articles of Incorporation for the Pembroke Pines Charter School Foundation, Inc., hereinafter referred to as "corporation" or "organization", filed January 17, 2004 with the State of Florida Secretary of State, as amended by the First Amendment dated March 2, 2005, amends the following provisions of the Articles of Incorporation, to read as follows:

- 1. **Article III** of the Articles of Incorporation is amended to read as follows:
  - The specific purpose for which this corporation is organized is to provide educational scholarships for teachers and students, and to provide financial support to Charter Schools operated by the City of Pembroke Pines. The corporation's purpose includes making monetary (or other capital assets) distributions to the Charter Schools operated by the City of Pembroke Pines, which further the educational programs and activities at the respective educational institutions. The corporation is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 2. All other terms contained in the Articles of Incorporation original filed on January 17, 2004, as amended by the First Amendment filed on March 2, 2005, not in conflict herewith, shall remain in full force and effect.
