## ARTICLES OF INCORPORATION OF

### NATIONAL ACCREDITING ASSOCIATION FOR CHRISTIAN SCHOOLS A FLORIDA NONPROFIT CORPORATION

Article 1. Name. The name of the Corporation is:

National Accrediting Association for Christian Schools, Inc.

Article 2. <u>Duration</u>. The duration of the Corporation is perpetual unless dissolved according to law,

### Article 3. Purposes. The purpose of the corporation is as follows:

A. This corporation is a not-for-profit corporation organized under Campter 5617, Florida Statutes. It is not organized for the private gain of any person. The pecific purposes of this corporation are:

To provide accountability and guidelines for Christian Schools. To certify Christian Schools and Christian School Teachers.

- B. To exercise all rights and powers conferred by the laws of the State of Storida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.
- Article 4. Members. At the time of incorporation, no membership qualifications are either established or expected. Should membership parameters be established, it will subsequently be stated in the by-laws.
- Article 5. <u>Initial Registered and Office.</u> The initial registered agent is <u>Fabienne</u> Naomi-Smith and the initial registered office 7304 Elvia Dr. Jacksonville, Florida 32211.

<u>Article 6. Initial Board of Directors.</u> The initial Board of Directors shall have <u>three</u> members whose names and addresses are:
