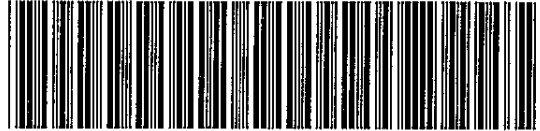

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized:


