ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S., (Not for Profit)

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be:

KEHILA TESHUVAH YISRAEL, INC

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

The general purposes for which this corporation is organized are exclusively religious, charitable, literary or educational with the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code. Without limiting the generality of the foregoing, Kehila Teshuvah Yisrael, Inc. is organized to act as a place of worship for the purpose of proclaiming the Gospel in an effective and efficient manner.

The corporation shall have the power to purchase, lease or otherwise acquire property, support missionaries and missions, raise funds, and do those things necessary to proclaim the Gospel in an adequate manner.

Notwithstanding any other provision of these articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal Income Taxes under Section 501(c)(3) of the Internal Revenue Code or corresponding provision of any future United States Internal Revenue law.

ARTICLE IV - MANNER OF ELECTION

The qualification for members and the manner of their admission are set forth in the Bylaws of the Corporation. The manner in which directors shall be appointed or elected will be determined in the Bylaws.
