

Articles of Dissolution

of

Reach Communications, Inc.

Pursuant to F.S.S. 617.1402 and 617.1403 of the Florida Statutes, Reach Communications, inc., a Florida not for profit corporation, hereinafter (the "Corporation"), submits the following articles of dissolution:

1. The name of the Corporation is Reach Communications, Inc.; and

- The effective date of dissolution is April 30, 2017; and
 The Corporation has no members and the dissolution was approved by the board of directors on the day of April 2017. The number of votes cast for dissolution was sufficient for approval; and
- 4. That all liabilities and obligations of the Corporation have been paid or discharged or that adequate provision has been made therefore; and
- 5. That all remaining property and assets of the Corporation have or will be distributed to Calvary Chapel Church, Inc., a Florida not for profit corporation and 501(c)(3) organization in accordance with its Corporations articles of incorporation; and
- 6. That there are no actions pending against the Corporation in any court or that adequate provision has been made for the satisfaction of any judgment, order or decree which may be entered against it in any pending action.
