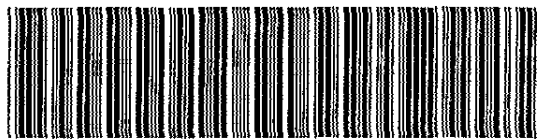

Space Coast Progressive Alliance, Inc.
A Florida Not For Profit Corporation

Article I: Name

The name of the corporation shall be: Space Coast Progressive Alliance, Inc.

Article II: Duration

The duration of the corporation is perpetual.

Article III: Purpose

- A. This Corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes and its purposes and actions will conform to the requirements of said statute. It is not organized for the private gain of any person. The specific purposes of this Corporation are to advance progressive policies at the local, state and national level through education on critical issues, coordination of activities among local and state progressive organizations, and providing internet resources. We are a grassroots organization of concerned citizens who strive for domestic and international policies beneficial to the well-being and self-determination of Americans and all peoples of the world, for protection of civil and personal liberties, and for progressive environmental, economic, labor, health care, social welfare, education, foreign, and defense policies.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

Article IV: Members

The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Voting and Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws.
