Article 8

No part of earnings of the organization shall insure to the benefit of, or be distributed to its members or other private persons except as reasonable compensation for services rendered. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on by (a) an organization exempt from federal income tax under section 501 (c) (3) of the internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article 9

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the organization shall not participate in, or intervene in any political campaign on behalf of any candidate for public office.

Article 10

Upon dissolution of Regina Caeli of Jacksonville, Inc., assets of the organization shall be distributed for one or more exempt purposes or to the federal government, or a state or local government, for a public purpose.
