The following Articles of Incorporation are submitted in compliance with the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes.

Article I. Name

The name of the corporation shall be: GFWC Arcadia Junior Woman's Club, Inc.

Article II. Principal Office and Mailing Address

The principal place of business of the Corporation is: 2288 N.W. American Legion Drive, Arcadia, Florida 34266

The mailing address of the Corporation is: P.O. Box 3340, Arcadia, Florida 34265

Article III. Purpose

The purpose for which the GFWC Arcadia Junior Woman's Club, Inc. (the "Club" or the "Corporation") is organized is voluntary community service - educational, literary, scientific and charitable. The Club shall be organized and operated exclusively for such purposes as enumerated within the meaning of section 501(C)(3) of the Internal Revenue Code and shall otherwise comply with any requirements for classification as an exempt organization under such section.

Article IV. Powers

The Club shall have such powers as are necessary to carry out its purpose and all incidental powers thereto; including the power to acquire, by purchase or otherwise, hold, use and maintain a suitable location(s) and building(s) for holding meetings for the use of the Club and its members; to acquire, hold, rent, lease, convey, mortgage or otherwise dispose of or encumber such other real and personal property as the Club may from time to time acquire or be possessed of; to execute all necessary notes, obligations, mortgages, leases, deeds and instruments of conveyance and to perform all the powers and duties incident to corporations; and to hold and to administer all funds of said Club and of its Departments.

Article V. Manner of Election of Directors

The Board of Directors shall be responsible for the general supervision and management of the Club and shall consist of:

(a) The officers (President, Vice President, Secretary and Treasurer) elected by majority vote of members present, provided there is a quorum. Officers shall serve: 11 a term of two years, beginning after the June installation; and

(b) The chairpersons of the departments and standing committees elected by the HALE members of their respective department or committee. Chairpersons shall serve at ORIDA

term of two years, beginning after the June installation; and

(c) The immediate past president.
