The undersigned incorporator, for the purpose of forming a Florida not-for-profit Corporation under the Non-profit Corporation iaw of Florida, does hereby certify that the Articles of Incorporation for Family Promise of Santa Rosa, Inc., are amended to read as follows as of 10/15/2022:

FIRST: The name of this Corporation is Family Promise of Santa Rosa, Inc. The name of the Corporation shall be changed from Family Promise of Santa Rosa, Inc., to Family Housing of Santa Rosa, Inc., hereinafter referred to as the "Corporation" as of October 15, 2022.

**SECOND:** The place in this state where the principal office of the Corporation is to be located is the City of Milton, Santa Rosa County. The principal place of business and mailing address is 5736 Stewart Street, Milton, Florida, 32570.

**THIRD:** Said Corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including such charitable purposes, to develop and provide services and facilities for homeless and low-income persons of the Santa Rosa County. Florida, area, including but not limited to providing food, clothing, shelter, and low-income housing.
