ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a Corporation under the **Florida Not For Profit Corporation Act**, Florida Statutes Chapter 617, adopts the following Articles of Incorporation.

ARTICLE I
NAME

ARTICLE II
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS


