

# ARTICLES OF INCORPORATION **OF** WHEN GOD LOVES A WOMAN, INC.

ARTICLE I: NAME

TALLAHASSEE, FLORIDA The name of this corporation shall be: WHEN GOD LOVES A WOMAN, INC.

#### ARTICLE II: PRINCIPAL PLACE OF BUSINESS

The corporation's registered office is located at:

#### ARTICLE III: DURATION

The period of existence of this corporation is perpetual.

#### ARTICLE IV: PURPOSE

This corporation is organized exclusively for religious, charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall

- A. Aid the poor and disadvantage individuals and families towards a life of self-sufficiency.
- B. The main objective of When God Loves A Woman, Incorporated (WGLAW) is to serve as a faith-based community organization, to empower women and girls of all ages and economically distressed communities by providing self development training, while providing job a life skills training, to promote self-confidence and empowerment
- C. Programs of When God Loves A Woman, Incorporated (WGLAW) will consist of shall not be limited to: educational opportunities, life skills, Bible Study groups, Self-Empowerment Programs, Anger Management, music engineering and producing, job replacement, land acquisition, employment, literacy, counseling, temporary shelter, teenage pregnancy, substance abuse awareness and prevention, tutoring, healthcare initiatives, childcare, elderly care, consulting, collaboration, ministry partnering and other programs to aid those in need.
- D. The property of this corporation is irrevocably dedicated to religious, charitable, and educational purposes and no part of the net income or assets of the organization shall ever insure o the benefit of any director, officer or member thereof of the benefit of any private person.

All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

#### ARTICLE V: ELECTION OF DIRECTORS

The manner of election of Directors, their terms of office and other provisions will be duly set forth in the Bylaws of the corporation.

#### ARTICLE VII: LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

- 1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;
- 2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and
- 3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.
- 4. The corporation shall not lend any of its assets to any officer or director of this corporation or guarantee to any person the payment of a loan by an officer or director of this corporation.

#### ARTICLE VIII: DEBT OBLIGATIONS AND PERSONAL LIABILITY

No member, officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or Directors be subject to the payment of the debts or obligations of this corporation.

#### ARTICLE IX: DISSOLUTION
