ARTICLES OF INCORPORATION

OF

RE-CREATION TAPPERS OF SOUTHWEST FLORIDA, INC.

The undersigned incorporator, for the purpose of forming a not for profit corporation in compliance with Chapter 617, F.S. (Not for Profit), hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be:

Re-Creation Tappers of Southwest Florida, Inc.

ARTICLE II

ARTICLE III

PURPOSE
