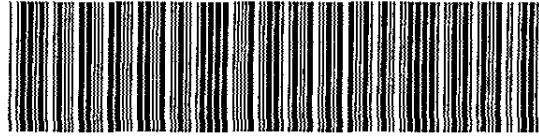

ARTICLE I NAME


