**ARTICLES OF INCORPORATION
OF
ASSOCIATION CAYENNE DE LA FLORIDE INC.**
Under Chapter 617 of the Not-for-Profit Corporation Law

IT IS HEREBY CERTIFIED THAT:

Article I The name of the Corporation pursuant to Chapter 617.04.01 of the Florida Statutes is: ASSOCIATION CAYENNE DE LA FLORIDE INC., hereinafter referred to as the Association Cayen and Cayenne are adjectives pertaining to the City of Cayes (also called Les Cayes or aux Cayes), the largest city and the seat of the Departement du Sud, a division of the Republic of Haiti.

Article II The association is a corporation pursuant to Chapter 617.02.02 of the Florida Statutes for Not-for-Profit corporations.

Article III The purpose or purposes for which the Association is formed are as followings: To encourage and support the officials and citizens of the City of Cayes and the Departement du Sud in their efforts to improve living conditions in their geographical area, for example by:

- (a) Promoting their resources, products, and services.
- (b) Assisting them in obtaining financial, technical assistance, and other participate for their projects.
- (c) Assisting them in obtaining scholarships for their children to pursue their education ,there or elsewhere.
- (d) Working with them to link the City of Cayes and adjacent towns with American municipalities as " sister cities".
- (e) Working with them to find sister parishes for their church communities.
- (f) Working with them to establish and maintain a website on the internet.
- (g) Implementing specific educational and economic development projects in the area.
- (h) Assisting recently arrived immigrants from the area who need help to settle in South Florida.
- (i) Promoting cultural, economic, travel and other exchange between officials and citizens of the area on the one hand and South Florida counterparts on the other

Article IV Place of business: All correspondence related to the Association shall be directed to the attention of : MARIE MICHELLE P.L.FRANCOIS, at the following address: 2022 Adams Street Apartment 108 Hollywood Fl, 33020.

Article V In furtherance of the foregoing purposes, the Association shall have all the general powers enumerated in Chapter 617 of the Florida Statutes for Not-for-Profit Corporations, together with the power to solicit grants and contributions for any Association purposes. The association shall have the right to exercise all other powers defined in its by-laws or incidental to the conferred powers.

Article VI Nothing herein shall require the Association, directly or indirectly, to engage in or include among its purposes any of the activities mentioned in Not-for-Profit Corporation Law.

Article VII The Board of Directors of the Association was selected at the general meeting followed by private consultation.

Article IX Notwithstanding any other provision of these articles, the association is organized exclusively for one or more purposes as specified in Section 501(c) (3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempt from federal Income Tax under IRC Section 501(c) (3) or corresponding provisions of any subsequent federal tax laws.

Article X No part of the earnings of the Association shall inure to the benefit of any member, trustee, director, officer of the Association, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Association), and no member, trustee, director, officer of the Association shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the Association.

Article XI No substantial part of the activities of the Association shall be devoted to carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Internal Revenue Code, Section 501(h), or participation in, or intervening in any political campaign on behalf of any candidates public office(including the publication or distribution of statements.)

Article XII In any taxable year in which the Association is a private foundation as described in Section 509(a) of the Internal Revenue Code of 1954, the Association shall distribute its income for a said period at such time and manner as not to subject it to tax under IRC Section 4942; and the Corporation shall not:

- a) Engage in any act of self-dealing as defined in IRC Section 4942(d);
- b) Retain any excess business holdings as defined in IRC Section 4943 (c);
- c) Make any investments in such manner as to tax under IRC Section 4944;
- d) Make any taxable expenditures as defined in IRC Section 4945 (d) or corresponding provisions of any subsequent Federal Tax Laws.

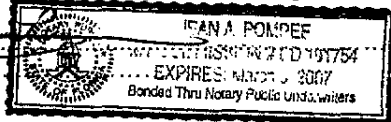

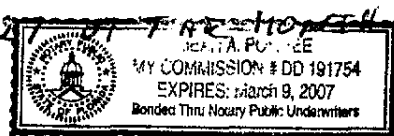
