ARTICLES OF INCORPATION OF

The undersigned subscribers to these Articles of Incorporation, desiring to form a corporation under the laws of the Sate of Florida, do hereby accept all the rights and privileges, benefits and obligations conferred and imposed by said laws and do hereby adopt the following Articles of Incorporation hereby organized pursuant to the Dade County Nonprofit code.

Article I.

Name

The name of the Corporation shall be: SALEM CHURCH OF GOD INTERNATIONAL, INC.

Article II Principal Office

Article III.

Terms of Existence

This corporation shall have perpetual existence as a nonprofit mutual benefit corporation.

Article IV.

Purposes and Powers

- (A) This Corporation is organized for the purpose of engaging in spiritual, charitable, vocational and educational purposes to aid poor and disadvantaged individuals and families toward a life of spiritual and moral uplift and self-sufficiency. The programs consist of but shall not be limited to: National and International Interdenominational Worship services according to the teachings of the Holy Bible and those of Jesus Christ, Spiritual Healing, Revivals, Workshops, Outreach Advocacy Programs for the Disadvantaged, Shelter, Orphanage, Educational Programming for Infants, Children, Youth and Adults, Cultural Arts, Literacy, Counseling, Teenage Pregnancy Prevention, Alternative Educational Opportunities, Job Training, Job Placement, And Acquisition, Prevention and Care of those living with HIV/AIDS, Elderly Services, Substance Abuse and other Programs to aide those in need. - (B) Notwithstanding any other provision of these Articles, The Corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) of the Internal Revenue Code.
