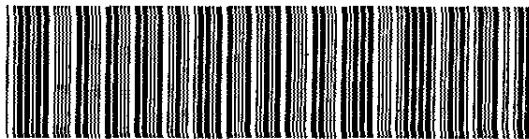

**Articles of Incorporation
of
Precious Children Enrichment Center, Inc.
A Nonprofit Corporation**

In compliance with chapter 617, F.S. (Not for Profit)

Articles of Incorporation of the undersigned, a majority of who are citizens of the United States, desiring to form a Non-Profit Corporation under the Corporation Law of State of Florida, do hereby certify:

Article I: The name of the corporation shall be:

Precious Children Enrichment Center, Inc.

Article II: The place in this state where the principle office of the Corporation is to be initially located is in the City of Deerfield Beach, Broward County.

Article III: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501c3 of the Internal Revenue Code, or the corresponding section of any future tax code. The specific purpose of the corporation is **to create a positive environment that afford children, youth and teens (ages 9 thru 17) can come together for educational, cultural, social, spiritual, physical gain and to enrich skills that build leadership characteristics and career development. To provide various workshops and training sessions that afford the opportunities for men, women, and families to better themselves in their community.**

Type of Business: To operate an Organization Benefiting Minors (s, 212.08(7) (I), F.S.) the primary purpose in which to provide activities those contributes to the development of good character and good sportsmanship and to education and provide cultural development for minors. To open a "day" recreation and leisure services business.

Articles V: No part of the net earning of the corporation shall inure to the benefit of or distribute to its board of directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of their articles, the corporation shall not, except to an insubstantial degree in any activities or exercise any powers that are not in furtherance of purposes of the corporation.

Articles VI: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 c 3 of the internal revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located.
