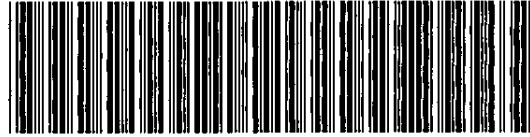



All other Articles of Incorporation filed on January 29, 2004 and any and all subsequent amendments previous to this name change remain unchanged.


This amendment shall be effective January 1, 2012 and is hereby signed and dated this 21st day of December 2011.
