The purpose for which the corporation is organized is:

The purpose(s) for which SAINT JOHN'S COLLEGE OF DIVINITY, INC. is organized are exclusively religious, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1985 or the corresponding provision of any future United States Internal Revenue law.

In compliance with F.S. 1005.06(f), SAINT JOHN'S COLLEGE OF DIVINITY will offer only educational programs that prepare students for religious vocations as ministers, professionals, or laypersons in the categories of ministry, counseling, theology, education, administration, music, fine arts, media communications, or social work.

### **ARTICLE IV MANNER OF ELECTION OR APPOINTMENT OF DIRECTORS**
