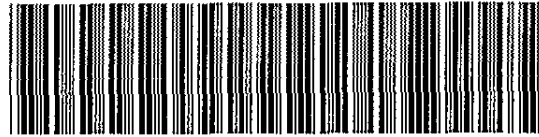

**Articles of Incorporation
For
Calvary of Aventura, Inc.**

THE UNDERSIGNED, acting as incorporators of a corporation under Florida General Corporation Act, adopted the following articles for such incorporation:

ARTICLE I

The name of the corporation is:

Calvary of Aventura, Inc.

The principal place of business of this corporation shall be:

Miami, Florida 33056**

ARTICLE II

The period of its duration is perpetual, unless dissolved according to law.

ARTICLE III

The general purposes for which this corporation is organized are exclusively religious, charitable, literary or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. Without limiting the generality of the foregoing, Calvary of Aventura, Inc. if organized to act as a church for the sole purpose of proclaiming the Gospel of Jesus Christ in an effective and efficient manner. This corporation shall have the power to purchase, lease or otherwise acquire property, support missionaries and missions, raise funds, and do those things necessary to proclaim the Gospel in an adequate manner. Notwithstanding any other provision of these articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal income Taxes under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue law.

ARTICLE IV

The qualification for members and the manner of their admission are set forth in the Bylaws of the Corporation. The manner in which directors shall be appointed or elected will be determined in the Bylaws.

ARTICLE V

The address of the initial registered office of the corporation is 20137 N.W. 36 Court, Miami, Florida 33056 and the name of its registered agent at said address is **Victoriano Batista**.

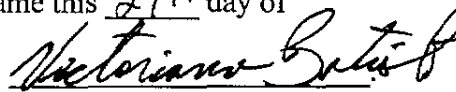
ARTICLE VIII

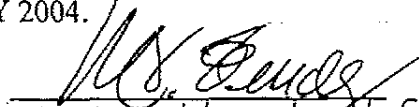

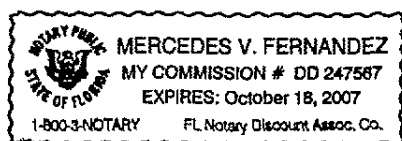
