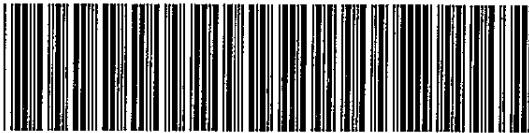

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I: NAME OF CORPORATION:

The name of the corporation is Project: Restoration, Inc.

ARTICLE II: PRINCIPAL OFFICE:

The principal place of business and mailing address of the corporation is 1498 Stafford Ave. Merritt Island, Florida, 32952.

ARTICLE III: PURPOSE

The purposes for which this corporation is formed are exclusively charitable and educational.

The purposes include the following:

1. restoring the biblical and historical truth of God's word regarding His commandments, His people, His land, and His coming kingdom,
2. bringing God's people to an intimate understanding of the Father's present purpose on this earth and how we fit into these plans,
3. enabling God's people to become the Holy nation the Father ordained from the beginning,
4. bringing the unity and joy that comes with mutual understanding and love between Jew and Gentile children of God, and
5. reaching the lost with the gospel of Christ.

In order to accomplish this mission, Project: Restoration will

1. coordinate and facilitate community-wide educational presentations and celebrations of God's biblically commanded holy days,
2. prepare and disseminate multimedia educational materials related to our purposes,
3. provide lecturers who make multi-sensory presentations regarding biblical truths to community, church, and school-based groups,
4. serve as consultants and project coordinators to other ministries with related purposes, and
5. do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others.

ARTICLE IV: MANNER OF ELECTION

The Board of Directors shall consist of a minimum of three directors. Directors shall be elected to the Board by a 2/3's majority vote of The Board of Directors. The directors shall serve indefinite terms until resignation or removal from office in accordance with the provisions of the Corporation's Bylaws, or death.
