1. The appointive officers shall consist of a president and Deacon and such other as the president may appoint with approval of the church.
2. The president or in absence the next next highest office vice president; Chairman and two executive committeeman in that order shall preside at all church meetings.
3. THE president may appoint members to a committee and may serve as an ex-officio member of any committee he or she appoint but never serve as chairman. He or She shall maintain order and Business as may come before him or her. Check issued by the Deacon may be countersigned by him.
