Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to Article IV (B) (2) of its Articles of Incorporation:

"CLASS B. The Class B member shall be Declarant who shall be entitled to one hundred (100) votes.
