ARTICLES OF INCORPORATION

ARTICLE I NAME

The Name of the Corporation (Ministry) shall be:

OUTREACH ISRAEL MINISTRIES, INC.

ARTICLE II

The principal place of business and mailing address of the corporation is:

1492 Regal Court Kissimmee, Florida 34744

ARTICLE III

The specific purposes for which this corporation is organized are:

- 1. To minister, to educate, to connect with and to reach out to people throughout the world, telling them about Israel, both the people and the Land, until the "restoration of all things." (Acts 3:21)
- 2. To assemble together people for the purpose of teaching, giving conferences/seminars, worship services and cultural and performing Arts demonstrations.
- 3. To broadcast, publish and distribute written, video, and sound audio literature, pertaining to the above.

ARTICLE IV DIRECTORS, MANNER OF ELECTION

The directors and manner in which the directors are elected or appointed

- A. The affairs of Outreach Israel Ministries, Inc. shall be administered by a Board of Directors consisting of not less than three (3) members.
- B. The Board of Directors shall be a self-perpetuating board and all successor directors shall be nominated and elected by said Board of Directors.
- C. The tenure of office of the members of the Board of Directors shall be indefinite and shallcontinue for life, or until the director shall resign or be dismissed for cause, or until such time as changed, in the by-laws, by a majority vote of the Board of Directors,
- D. There may also be such additional Boards and/or committees as shall be determined from time to time, by the President and or the Board of Directors.

E. No person shall serve, nor continue to serve, as a member of the Board of Directors who does not subscribe to the purposes of this ministry as set forth in Article 3 of these Articles of Incorporation.

ARTICLE V OFFICERS

The officers of this corporation shall consist of a President, a Vice-President, a Secretary, a Treasurer, (the office of secretary and treasurer maybe combined), and such additional officers as may be deemed necessary and appointed or elected by the Board of Directors. The duties of each officer shall be as provided in the by-laws.

ARTICLE VI MEMBERSHIP

Membership in this ministry shall consist of two (2) different types, regular membership and honorary membership.

- A. The regular, or voting, members of this organization shall be the Board of Directors.
- B. Honorary membership in this ministry will be given to those who support this ministry.

Honorary members shall have no voting rights nor any say in the way this ministry is run but shall, be issued a certificate of honorary membership or honorary affiliation.

ARTICLE VII TERM OF EXISTENCE

This Corporation is to exist perpetually.

This corporation shall have by-laws which shall be approved by a two thirds (2/3) vote, of the regular or voting members of this corporation at a regularly scheduled annual meeting of this corporation.
