**ARTICLES OF INCORPORATION
OF

a Florida corporation not for profit**

The undersigned incorporator by these Articles associates himself for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, and adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this Corporation is Toad Hollow Condominium Association, Inc.

ARTICLE II. TERM OF EXISTENCE

This Corporation is organized for the purpose of providing an entity under the Florida Condominium Act (the "Act"), for the operation of a condominium located in Franklin County, Florida, and known as "Toad Hollow, a Condominium", created pursuant to the Declaration of Condominium therefor and shall exist perpetually or until terminated as provided by law.

ARTICLE III. ADDRESS OF CORPORATION

The purpose of this Corporation will be to operate and govern the condominium known as "Toad Hollow, a Condominium", located in Franklin County, Florida.

ARTICLE VII. BOARD OF DIRECTORS

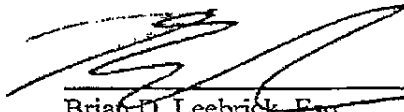
The election or appointment of the Board of Directors shall be regulated by a method of election as stated in the By-Laws of the Corporation.
