

1. Article I is deleted in its entirety and replaced with the following new Article I:

"Article I.

Seraphic Fire's mission is to present high-quality performances of under-performed music with cultural significance to audiences in South Florida. At the same time, Seraphic Fire aims to encourage the occupational advancement of young musicians by providing a forum for development and presentation of their talents."

- 2. Article III(b) is amended by deleting the first sentence thereof and replacing it with the following new first sentence: "Any person performing services or donating time or resources to Seraphic Fire, Inc., shall be eligible for membership."
- 3. Article VI(a) is amended by deleting the first sentence thereof and replacing it with the following new first sentence: "The business of the Corporation shall be conducted by a Board of Directors consisting of no fewer than five (5) members, the exact number to be determined in accordance with the by-laws."
