

The UNDERSIGNED, natural persons of legal age acting as incorporators of a not-for-profit corporation under Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such applicable corporation.

## ARTICLE I - NAME

The name of this corporation is THE NATURAL HEALTH FOR CHILDREN FOUNDATION, INC.

# ARTICLE II - DURATION

The period of its duration is perpetual.

#### ARTICLE III - NATURE OF BUSINESS

The purpose(s) for which this corporation is organized are: "To operate a Not-for-Profit Foundation to help parents and children who want to have a natural method of living. The foundation will help them by teaching, coaching and demonstrating:

- . how to be nature friendly
- . how to consider the human being as one in body, mind and soul
- . how to choose food and nutrients in order to have a fulfilling and long healthy life.

#### ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are qualified, elected or appointed is as follows: Each year at its General Annual Meeting, the members of the corporation shall elect a board of directors to serve for the ensuing year as provided for in the by-laws.

## ARTICLE V - REGULATION OF INTERNAL AFFAIRS

The Internal affairs of the corporation are governed by the "BY-LAWS" which shall be established and approved by a majority of the directors at the first meeting of the board of directors.

#### ARTICLE VI – LIMITATION CORPORATE POWERS

The corporate power of this corporation is as provided in section 617.0302, Florida Statutes. There are no provisions limiting the powers of the corporation except as prohibited by section 617.0833

#### Section I.

This corporation shall be operated and governed by a Board of Directors. - a. The number of directors may be provided for in the by-laws but shall at times not be less than FIVE (5);
- b. The Board of Directors has power to make, alter, or rescind all such by-laws and regulations to rule the business of the corporations as will not be inconsistent with these Articles, or of the laws of the State of Florida. All changes must be ratified by two thirds (2/3) of the membership of the corporation.


