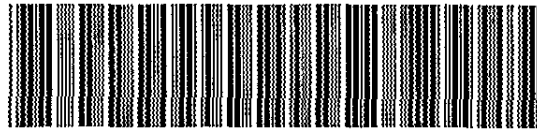

ARTICLES OF INCORPORATION OF ZION HOPE
MISSIONARY BAPTIST CHURCH OF MIAMI, INC.
A NON PROFIT CORPORATION

The undersigned incorporator for the purpose of forming a Non For Profit Corporation under the Laws of the State of Florida not-for-profit under the following proposed charter.

ARTICLE ONE

The name of the corporation shall be ZION HOPE MISSIONARY BAPTIST CHURCH OF MIAMI, INC. and the address of the principal office shall be: 5129 N.W. 17th Avenue, Miami, Florida 33142, or such other places as its Board of Directors may from time to time determine and designate.

ARTICLE TWO

The general nature and object of the corporation shall be:

- (a) to buy, purchase, sell or acquire, equip. maintain and provide facilities for the conduct of religious services and for the operation of school facilities;
- (b) to raise funds through contributions, pledges, bonding, solicitation and acceptance of gifts or money, tangibles and intangibles, in order to carry out the purpose of the corporation;
- (c) to issue bonds, notes, checks, debentures and evidence of indebtedness, and to secure same by mortgage or trust or otherwise;
- (d) to promote the teachings of Jesus Christ, our Blessed Savior, in accordance with the Baptist Theology.

ARTICLE THREE

The number of members of the corporation shall be unlimited. No member of the corporation shall be deemed to have, or have acquired any right, claim or interest in or to any of the corporate property by virtue of his or her membership. Qualification for membership is belief that Jesus Christ is the son of God. Manner of admission is Baptism by water.

ARTICLE FOUR

This corporation shall have perpetual existence.

All revenue, proceeds, income, money, property donated or acquired both tangible and intangible, received from the conduct of such church operations shall be used and employed for the promotion and the conduct of the church operation for the payment of all operating expenses, and for the payment of salaries of any employees, which salaries are to be determined by the Board of Directors.

ARTICLE TEN

Any amendment to the Articles of incorporation shall be made by the Board of Directors at a meeting properly noticed in accordance with the by-laws of the corporation.


ARTICLE ELEVEN

ARTICLE TWELVE

In the event of dissolution, the residual assets of the corporation shall be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c) of the Internal Revenue Code of 1954, or corresponding sections of any prior or future Internal Revenue Code, or to the federal, state or local government exclusive public purpose.

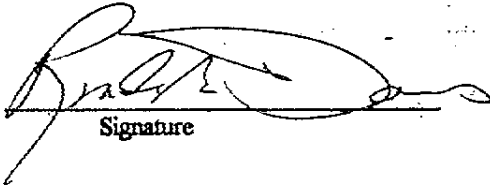
