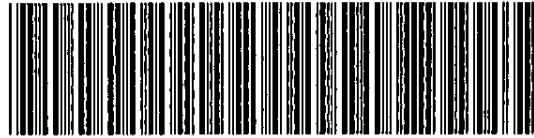

#### **DEFINITION AND PURPOSE OF THE CHURCH**

Those who are baptized believers in Jesus Christ comprise the local church body whose profession of faith is evident in their daily walk with Christ. (John 4:1, Matt 28:19, Acts 2:47, Romans 16:16 and Revelations 1:4)

The church is recognized as a place where Christians can gather together in worship and fellowship with one another in offering praises to God and sharing and receiving God's Word. It is a place the two ordinances of Baptism and the Lord's Supper are administered to the glorification and edification of God.

The general nature and object of the corporation shall be:

- To buy, purchase, sell or acquire, equip maintain and provide facilities for the conduct of religious services and for the operation of school facilities;
- To raise funds through contributions, pledges, bonding, solicitation and acceptance of gifts or money, tangibles and intangibles, in order to carry out the purpose of the corporation;
- To issue bonds, notes, checks, debentures and evidence of indebtedness, and to secure same by mortgage or trust or otherwise;
- To promote the teachings of Jesus Christ, our Blessed Savior, in accordance with the Baptist Theology.
- a place of worship for both believers and non-believers
- a place of fellowship, teaching and nurturing through God's Word
- an atmosphere of total praise and worship
- Christian Counseling
- Feeding The Hungry
- Solemnizing Holy Matrimony (Marriages)

## AMENDMENT TO ARTICLES OF INCORPORATION

### ARTICLE III

The number of members of the corporation shall be unlimited. No member of the corporation shall be deemed to have, or have acquired any right, claim or interest in or to any other corporate property by virtue of his or her membership.

**Qualifications for membership** are belief that Jesus Christ is the Son of God and the Articles of Faith according to fundamental Baptist doctrine. Manner of admission is Candidate for Baptist; Letter or by Christian Experience.

1. **Baptism** – by a profession of faith in the Lord Jesus Christ and consent to water immersion.
2. **Letter** – a recent member of a prior church in good standing and desiring to join this church and can provide a letter from the prior church certifying the particulars (date, time, and place) of their baptism.
3. **Christian Experience** – a former member of another Baptist church, whose membership had lapsed, may be restored on a profession of their faith and evidenced of that faith. Any member that had been placed on the inactive roll or excluded from the membership of this church may, upon recommendation of the church body, be restored.

**Termination of membership is as follows:**

1. **Physical death.**
2. **Transfer** – When it is so requested, the church may grant to a departing member in good standing, a letter of dismissal to the fellowship of another church. No such letter may be given to a member who is under corrective discipline.
3. **Exclusion** – If a member is habitually absent from scheduled church meetings for a period of more than 90 days without proper justification or contact, said member may be excluded from active membership. The inactive member loses his/her voting privileges.
4. For consistent infractions of the stated Articles of Incorporation and By-Laws.

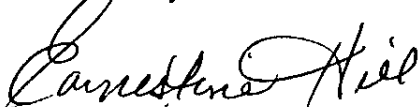
**IN THE EVENT OF DISSOLUTION**
