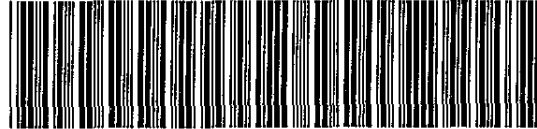

The undersigned, for the purpose of forming a non-profit corporation under the laws of the State of Florida, do hereby adopt the following articles on incorporation.

ARTICLE ONE

The name of the Corporation is:

ARTICLE TWO

CORPORATE DURATIONS:

The duration of the Corporation is perpetual, unless dissolved according to law. The Corporation existence shall commence upon the date of subscription and acknowledgment (Notarization.)

ARTICLE THREE

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are: Educational and charitable, more particularly;

1. To advocate on behalf of and defend the rights of the residents of Roosevelt Park Resident Association, Inc. and to revitalize the community and enhance the quality of life for its members and all citizens.
2. To engage in any other enterprises or lawful businesses which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing community and corporate acts and objectives.

ARTICLE FOUR

QUALIFICATIONS

The Qualifications for members and the manner of their admission are: Members must be a member of a household, in the sub-division covered by the association and as per the By-Laws established herewith.

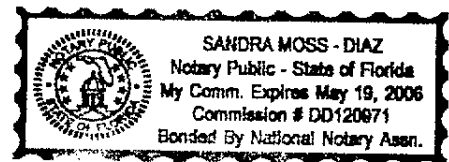
