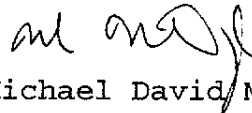

**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following articles of incorporation.

**ARTICLE I**

The name of the corporation shall be "THE CALVARY CHURCH OF ROYAL PALM BEACH, FLORIDA, INC."

**ARTICLE II**

The principal place of business and mailing address of this corporation shall be 100 Ponce de Leon Street, Royal Palm Beach, Florida 33411.

**ARTICLE III**

The specific purposes for which this corporation is organized are to establish and maintain a place for the worship of the Almighty God, our Heavenly Father, to provide for Christian fellowship for those of like precious faith where the Holy Ghost may be honored according to our distinctive testimony and to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and abroad.

**ARTICLE IV**

The manner in which directors are elected or appointed is as

follows. There shall be four directors for this corporation. Magdaleno R. Torres shall be one of those directors for so long as he remains the pastor of The Calvary Church of Royal Palm Beach, Florida, Inc. If he should decide to resign from the position of pastor, his successor pastor shall become one of those directors for so long as he remains the pastor. Whoever the pastor shall be at the time shall appoint a second director who shall serve for a period of one year, and, after that one year period, the, then, pastor shall appoint a director each and every year thereafter who shall serve for a period of one year. The remaining two directors shall be approved by a majority vote of the members of the congregation of The Calvary Church of Royal Palm Beach, Florida, Inc., from those whose names the, then, pastor shall submit to them. If the majority of those members do not approve of such individuals, the pastor shall submit additional names to those members until the majority of those members approve of such two additional directors each of whom shall serve for a period of one year from the date of his or her approval.
