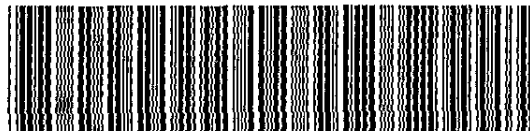

ARTICLE I

NAME

The Name of this corporation is: CHURCH OF GOD (UNIVERSAL) MIAMI, FLORIDA, INC

ARTICLE II

ARTICLE III

PURPOSE

The Corporation is a not-for profit corporation organized under Chapter 617. 0301 Florida Status. ARTICLE X

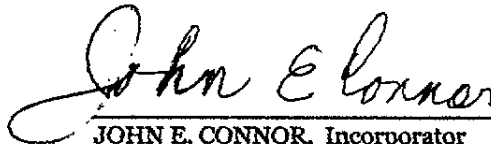
CAPITAL STOCK
