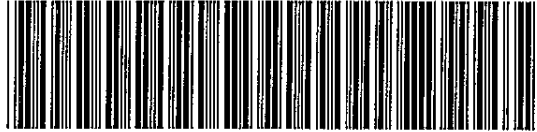

Pursuant to the Laws of the State of Florida, the undersigned adopts the following article of incorporation.

Article II.

Corporate Name

The name of this non-profit corporation is PRAISE, POWER AND COMPASSION MINISTRIES, A DOMESTIC NON-PROFIT CORPORATION.

Article III.

Nature of Business and Powers

The general nature of the business to be transacted by this Non-Corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article IV.

Term of Existence

This Non-Profit Corporation shall have perpetual existence commencing upon filing of these Articles of Incorporation.

Article V.

Registered Agent and Initial Registered and Principal Office

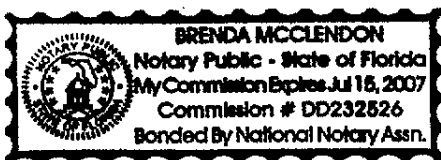
