Articles of Incorporation

of

The undersigned subscribers to these Articles of Incorporation, desiring to form a not-for-profit corporation under the laws of the State of Florida, do hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and do hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

Article I. Corporate Name

The name(s) of this Corporation shall be:

Article II. Terms of Existence

This corporation shall have perpetual existence

Article III. Purposes and Powers

This Corporation is organized for the purpose of engaging in all lawful activities permitted to not-for-profit corporations organized under the Florida General Corporation Act, as in effect from time to time.

This non-profit is organized for the purpose of engaging in religious, charitable and educational missions to assist persons toward a life of self sufficiency. To provide a safe, secure and structured facility for intergenerational programming and projects that will include but not be limited to Interdenominational Faith Based Education, Workshops, Seminars and Lectures, Community Development, Low to Moderate Income Housing, Business Development, Extended Child Care Services, Senior Care Services, Clothing and Feeding Programs, Literacy, Life Skills, Preventative Programs directed at deterring Substance Abuse, Child Abuse, STD's, HIV/AIDS, Truancy, Delinquency, and Criminal Activities. To provide shelter to the Homeless, to victims of Domestic Violence, and temporary shelter to criminal offenders and others in need of temporary shelter. All of the contained programs, services and projects will be operated within the guidelines and meaning of the state of Florida's non-profit corporations and in accordance of the Federal Tax Exempt Statues within the meaning of the 501 (c) (3).
