Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Articles III. Purposes and Powers

Said corporation is organized exclusively for charitable, religious and educational purposes, including intergenerational programming and projects whta will include, but not be limited to Interdenominational Faith based Education, Workshops, Seminars and Lectures, Community Development, Low to Moderate Income Housing, Business Development, Extended Child Care Services, Senior Care, Clothing and Feeding Programs, Literacy, Life Skills, Preventative Programs directed at deterring Substance Abuse, Child Abuse, STD's, HIV/AIDS. Truancy, Delinquency, and Criminal Activities. To provide shelter to the Homeless, to victims of Domestic Violence and temporary shelter to criminal offenders and others in need of temporary shelter.

No part of the net earnings of the corporation shall inusre to the benefit of, or be distributed to its members, trustees, directors, officers and other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance pf Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes with the meaning of Section 501 (c)(3) of the Internal Recenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.
