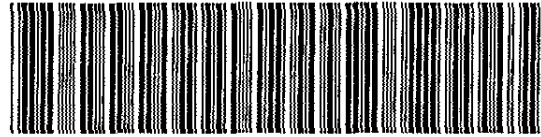

The undersigned, acting as incorporator of a corporation pursuant to chapter of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be Lord's Christian Services, Inc.

ARTICLE II

The principal place of business of the corporation shall be 301 East Pine St, #150 ,Orlando, FL. 32801 . The mailing address of the corporation shall be P.O. Box 780402, Florida, 32878.

ARTICLE III

This corporation is organized exclusively for charitable, religious, and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c-3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

The method of appointment of the trustees shall be stated in this corporation bylaws.

ARTICLE V

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of this corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles,

this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 510 (c-3) of the Internal Revenue Code (or) the corresponding provision of any future federal tax code), or (b) by a corporation, contributions to which are deductible under section 170 (c-2) of the Internal Revenue Code (or the corresponding provision of any future federal tax code).

ARTICLE VI

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c-3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of this corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

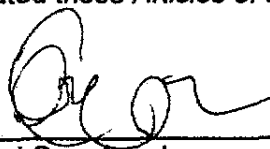
