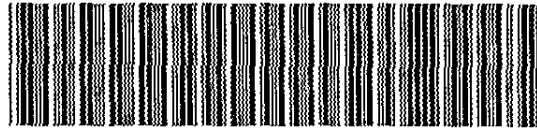

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

The Center for International Citizenship Education, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

:

- A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The purpose for which the corporation is organized is to foster the concept of responsible world citizenship among the peoples of the world, particularly with respect to the environment and the diversity of human cultures. To further its mission The Center for International Citizenship Education, Inc. (CICE) promotes the teaching of English as an international language in order to facilitate communication among the peoples of the world, and also encourages the learning of second languages in the United States in order to broaden American understanding of the value of cultural diversity. CICE facilitates the exchange of arts and culture internationally to celebrate both human diversity and our common humanity as one people sharing a small planet.**
- B. CICE shall exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit Corporations.**

- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected shall be as follows:

The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.
