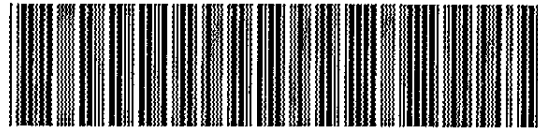



**ARTICLES OF INCORPORATION**

(Not for Profit)

**ARTICLE I. CORPORATE NAME**

The name of the corporation shall be Cedar Key Land Preservation Corp.

**ARTICLE II. PRINCIPAL OFFICE**
