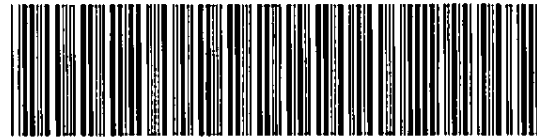



Article IV - Purpose

This corporation is organized not by way of limitation, the educational and religious purposes of the Corporation shall include developing and operating one or more private pre-schools, elementary schools, middle schools and secondary high schools, each with the purpose of providing formal instruction to a defined, regulary enrolled, group of students through the use of full-time and part-time duly and properly credentialed teachers and teaching assistants, with a formal curriculum focusing on both academic and religious information.

Said Corporation is organized exclusively for scientific, charitable, literary and educational purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501c3 of the Internal Revenue Code, or corresponding section of any future federal tax code.

Subject to the limitations as set forth in Article IV, in accomplishing the foregoing purposes, the Corporation will be authorized to exercise all powers of a not-for-profit corporation organized under Chapter 617, Florida Statutes.


