ARTICLE I – NAME

The name of this corporation shall be known as Young Minds Adapting and Achieving Foundation, Inc. This corporation shall not join, belong, or pay dues to any other corporation. However, members may do so if they desire to.

ARTICLE II – PRINCIPLE OFFICE

The principal place of business for the corporation shall be 1426 East Mowry Dr., Suite 208 Homestead, FL 33030.

ARTICLE III – PURPOSE

The purpose of Young Minds Adapting and Achieving Foundation is:

- A] To conduct activities which are exclusively charitable, literary, and educational within the meaning of the section 501C3 of the Internal Revenue Code, as the same may be amended from time to time.
- B] To provide youth of economically distressed urban and rural communities with access to information, technology, and training and how to use it.
- C] To supplement high school educational services by providing academic enrichment programs, study skills, and occupational skill training, and tutoring. Hence, promoting the value of a college education.

- D] To provide mentoring programs to improve academic achievement and reduce drop out rate.
- E] To provide resources pertaining to Youth Crisis, Violence, HIV, Drugs, Drunk Driving, sexual Abuse, and of the like.

ARTICLE IV – MANNER OF ELECTION

The Board of Directors is a group of persons vested with the administrative excellence to govern the affairs of this corporation through the guidance of the Holy Spirit and Integrity of the Word of God. All candidates who desire to obtain a position of Director must meet the following prerequisites:

- A] Active supporter of Young Minds Adapting and Achieving Foundation, Inc. of minimum of 1 year.
- B] Must have experience working with children.
- C] Must be a person of love, compassion, self -respect, and an example in the community.
- D] Must be a person who desires to help and assist youth and reach out to them with kindness.
- E] Person who does not live a life of dishonesty, misconduct, debauchery or licentiousness behavior. Involvement in such activities disqualifies the candidate from all consideration to occupy any position or office in this organization. However, those who conduct themselves honorably, morally, and ethically shall be considered.

After all prerequisites have been met and a carefully examination of the applicants, the Board of Directors will either approve or disapprove the applicants by a 2/3 vote by way of a secrete ballot. The applicants will be notified within 14 business days as to the decision made.

If the approved candidates is believed and/or found guilty of treachery or bribery at any level, the CEO will reject the approved candidate and will appoint another candidate to occupy the position. Furthermore, a special panel appointed by the CEO will perform an extensive investigation immediately.
