# **ARTICLES OF INCORPORATION**

### A Nonprofit Organization

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

#### **Article 1**

The name of this corporation is: <u>Hope For Tomorrow Scholarship Foundation</u>. Inc.

#### Article 2

The name and address of the registered agent and registered office of this corporation is: Kevin Myles, 14285 SW 287<sup>th</sup> Street. Leisure City, FL 33033.

#### Article 3

The purposes for which this corporation is organized are: To provide scholarships for those seniors in high school in Miami-Dade County who have excelled both academically and athletically: To provide scholarships for those high school seniors who have proven their leadership qualities both in the classroom and on the playing field; To level the playing for those high school seniors who may not otherwise be recognized by their respective schools for their accomplishments.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501 (c) 3 of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) 3 of the Internal Revenue Code or corresponding section of any future federal tax code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501 (h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) 3 of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
