ARTICLES OF INCORPORATION

6AM INTERCESSORY PRAYER WARRIORS CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt (s) the following Articles of Incorporation:

ARTICLE I Name of Corporation

The Name of this Corporation shall be 6AM Intercessory Prayer Warriors Corporation

ARTICLE II Principle Office

The principle office of the corporation shall be 470 W. 33rd Street, Riviera Beach, Florida 33404 County of Palm Beach, and any other such office or place that the Board of Directors may deem from time to time as per space and facilities needed.

ARTICLE III Statement of Purpose

This organization is for charitable purposes within the Internal Revenue Statute for a not-for-profit organization. To prepare men and women with the knowledge of God the father and Jesus the son of God so that they can go out and proclaim the gospel of Jesus Christ. To open doors of opportunities for those members to attend Bible Seminary so that they may further their knowledge in Gods word and obtain their degree in Biblical theology. To provide food and clothing ministries to seniors and families in need, to offer educational, employable and self-esteem workshops and other referrals or resources as per individual or family need.

To develop and implement innovative approaches to stimulate economic development. To enhance community development through rehabilitation of existing substandard buildings and construction of new facilities in the place of blighted structures for the purpose of combating the deterioration of the community, contributing to its physical improvement and provide multi services for seniors, families and individuals who are in need.

ARTICLE IV The manner in which the directors are elected or appointed is:

For the first fiscal year the board members will be appointed by the Incorporator, and a general vote by the appointed board members will decide thereafter.

ARTICLE VIII

The initial Regulation and Management affairs of the corporation will be the responsibility of the incorporator however, approved prior to implementation of such business regulations and business affairs will be the decision of the appointed Board of Directors. No substantial part of the activities of the corporation or organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation or organization shall not participate in, or intervene in any political campaign on behalf or, or in opposition to any candidate for public office.
