The undersigned subscriber(s) to these Articles of Incorporation is a natural person(s), having the age of <u>18</u> or more, a majority of whom are citizens of the United States, desiring and competent to form a non-profit corporation under the Non-Profit Corporation Law of Chapter 617 of the Florida Statutes, do hereby certify:

#### Article I

#### **Article 2 – PRINCIPAL OFFICE**

#### **ARTICLE 14 – AMENDMENT**

These Articles of Incorporation may be amended in the manner provided by law, Every amendment shall be approved by the Board of Directors, proposed by them to the Members, and approved at a Members meeting by a majority of the Members, unless all the Directors and all the Members sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
