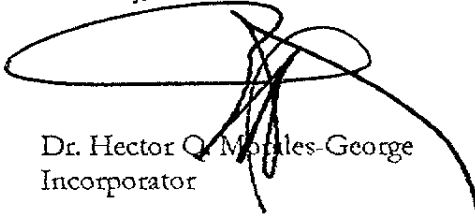

The undersigned, acting as incorporator(s) of a corporation pursuant to *Chapter 617, Florida Statutes*, adopt(s) the following Articles of Incorporation:

**FIRST:** The name of the corporation shall be:

**PARTIDO LIBERAL CUBANO, Inc.**

**SECOND:** The principal business and mailing address of the Corporation is:

**2272 SW 7<sup>th</sup> Street Miami, Florida 33135**

**THIRD:** The specific purpose(s) or Mission Statement for which the

Corporation is organized is to unite all exiled cubans of good faith in order to accomplish the freedom of our homeland Cuba. We strive to rescue the abduction of our country over forty-five years ago by democratic means. Once the freedom of our country is accomplished we must, unite all efforts and skills available within our members and community in order to restore our freedom. Also to rebuild and restore all the Human Rights as the main objective granted by the Cuban Constitution of 1940 as our best foundation of Laws to institute a Democratic New Republic To procure the happiness and freedom of all the Cuban nationals. It is intended that the corporation shall have the status of a corporation that is exempt from federal income taxation under **Section 501(a) of the Code**, as an organization described in **Section 501 ( c) (3)** of the Code. These Articles of Incorporation shall be limited accordingly. The Corporation shall not carry on propaganda or otherwise attempt to influence legislation to such extent as would result in

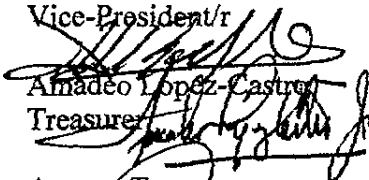
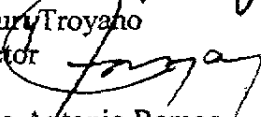
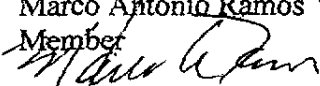
loss of its exemption from **Federal Income Tax Section 501(c) (3)** of the Code.

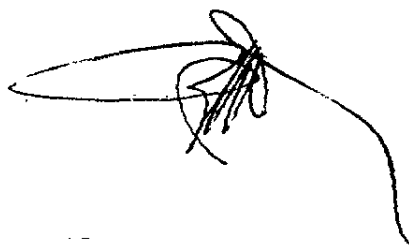
Further, the corporation shall not participate in or intervene in (including the publishing or

distributing of statements) any political campaign on behalf or in opposition for any candidate for public office.

**FIFTH:** The corporate powers of this Corporation are as provided in **Section 617.0302, Florida Statutes**, unless limited are as follows: only as limited by the laws of **PARTIDO LIBERAL CUBANO, INC.**

**SEVENTH:** The Affirmative vote of two thirds (2/3) of the total Directors shall be required to adopt or approve the following actions:

- 1) Liquidation or dissolution of the Corporation; or,
- 2) Merger, consolidation or transfer of substantially all the assets of the Corporation, and;
- 3) Repeal, modification, amendment, in whole or in part, or addition to the Articles of Incorporation or By-Laws of the Corporation or adoption of new Articles of Incorporation or By-Laws.
- 4) Change in the number of Directors

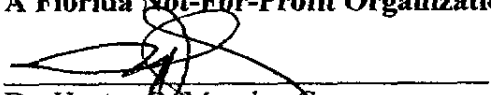
The notice of the meeting at which any such action is to be considered shall set forth the subject of the action or actions to be approved.

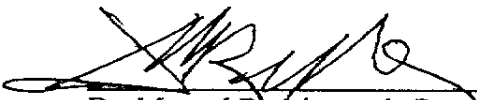
**EIGHTH:** Except as provided in the Article **SEVENTH**, the affirmative vote of a majority of the Directors shall be required for the authorization or taking of any action by the Directors.

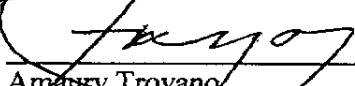
**NINTH:** Upon the dissolution of the Corporation, the Directors, shall after paying or making provisions for the payment of all liabilities of the Corporation, distribute all of the assets of the Corporation to the Federation, provided that the Federation in then a qualified organization. If the Federation is not a qualified organization, then the assets of the Corporation shall be distributed only to qualified organizations. If the Directors cannot agree upon a qualified organization the Directors shall transfer all of the above assets of the Corporation to a court of competent jurisdiction for disposition.

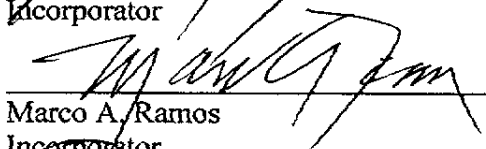

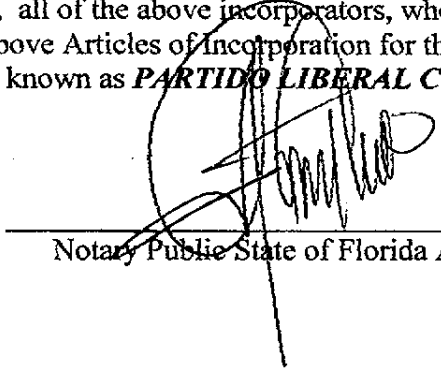
