ARTICLES OF INCORPORATION BANGLADESH AWAMI LEAQUE FLORIDA, INC A FLORIDA NONPROFIT CORPORATION

The undersigned incorporator hereby forms a corporation under chapter 617 of the laws of the State of Florida.

ARTICLE I. CORPORATIE NAME & ADDRESS
