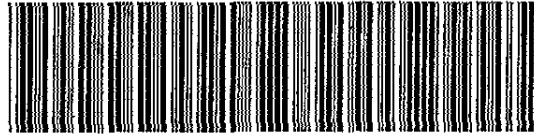

The undersigned subscribes to these Articles of Incorporation, each a natural person, competent to contract, hereby associate themselves together to form a Corporation for non-profit under the Laws of the State of Florida; Chapter 617.0202, FS; and further do agree to the following conditions of said Corporation:

ARTICLE I

The name of this Corporation shall be: "FIRST METHODIST UNIVERSITY – STAR OF DAVID, INC."

ARTICLE II

The General nature of business to be transacted by this Corporation and the objects and purposes thereof are as follows:

The purpose of which this Non-Profit Corporation is organized: "TO PROVIDE CONSULTING AND EDUCATIONAL SERVICES".

ARTICLE III – ADDRESS



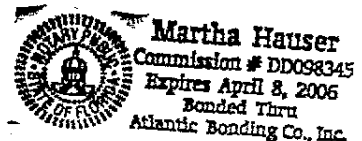
