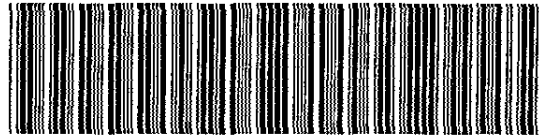

ARTICLE I

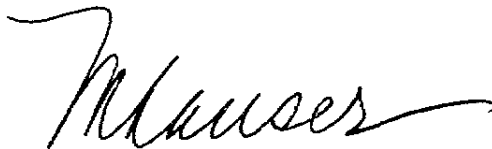
